

# COMMITTEE FORMED

On May 27, 1979 the annual meeting of the USA Rugby Football Union was held. In a move of support for women ruggers a Women's Committee was formed. Elissa Augello, President of the Midwest Women's Rugby Football Union, was named as chairperson.

# FIRST MEETING HELD

The first USARFU Women's Committee meeting was held September 1, 1979 in Arlington Heights, Ill. Representatives were present from California, Florida, Georgia, Illinois, Maine, Massachusetts, Michigan, New York, Texas, Washington and Wisconsin.

# HISTORIC FIRST: USARFU WOMEN'S COMMITTEE

The purpose of the committee is threefold:

- To improve national communication through contact lists, tournament lists, and a national newsletter - IN SUPPORT.
- 2.) To develop higher skill levels in women's rugby through shared clinics, films, and intraterritorial competition.
- 3.) To develop a working relationship between men's and women's rugby organizations at every level.

The women rugby leaders discussed the relationship between women's rugby and rugby football unions. In Pennsylvania, Mississippi, Alabama, S. Carolina, and Florida, women's status is either vague or not acknowledged at all. In the Midwest, women have been refused membership in the union. As a result the Midwest Women's RFU was formed.

The situation is more positive in other locations. In California women receive full membership upon payment of dues. In Georgia, women (continued on page 4)

# Women's Sports Foundation Membership Drive

In 1974 Billie Jean King founded the Women's Sports Foundation. Its purpose is to encourage women and girls to participate in sports for their health and personal develop-

The Foundation is also a lobbying force for equal opportunities in women's athletics. In addition, they are a vehicle for developing skills through films, scholarships, and educational material.

At the beginning of the rugby season each club must contend with finances. Even for those few clubs lucky enough to find sponsors, the sponsorship rarely covers little more than half of the expenses, if that.

The Women's Sports Foundation is offering SCWRFA \$5.00 for every \$12.50 membership sold. SCWRFA has agreed to share the profit with each individual club. \$2.50 per membership goes to the club and the remaining \$2.50 goes to the league.

This is a unique opportunity to benefit your club and your Association at the same time. A club cannot function without funds. Southern California Women's Rugby Football Association cannot func-

tion without funds.

# Not Masculine, Not Feminine Just Human!

What are the reasons for this phenominal growth in a sport many people thought would be abandoned by women after their first tackle? Realization of one's own ability and potential. Frequently that first tackle, rather than send women running back home, dismissed many myths that women had been taught. They discovered a new dimension of life - the use and power of their own body and mind. They didn't break when tackled; they enjoyed the contact of tackling; they realized the potential of their muscles and lungs to perform; they found they actually enjoyed the company of these freespirited women who formed a team of which they were an integral part. In short, they enjoyed rugby for the same reasons as men. Except now the myth has exploded.

Certainly women's rugby contains great tervor; it is not, however a religion. (con't. on page 8)



# MIDWEST WOMEN TOUR BRITAIN



In April of last year an article expression Rugby - "Wanted: Women Ruggers for Tour". Pam Tittes, President of the Minnesota Women's RFC, was trying to organize an exhibition tour of the British Isles. She succeeded.

During August the thirty-five women, representing 12 Midwest clubs, toured from Glasgow to London. They played five games in ten days, sightseeing in between.

Newspaper coverage was extensive The tour although often sarcastic. also received coverage on BBC TV National News.

According to Ms. Tittes the newspaper articles were the least acceptable part of the tour. They received a warm reception in all of their game locations: Elgin, Scotland; New port, Wales; Fleetwood, Bristol, and London, England. The host clubs also provided lodging.

"People on the sidelines heckled us at first. Then something interesting happened. The rude comments stopped as the spectators became involved in the game. Soon they were just watching us play rugby."

Overall, the women agreed it was an exhausting but tremendous experience. Even the tone of the newspaper articles became more positive as the tour progressed.

serve on the board of directors in addition to membership rights.

In terms of the status of women within the USARFU structure, the committee concluded the following:

- 1.) Women, as rugby players, are disturbed that a distinction exists between men's and women's rugby. We all play rugby.
- 2.) In as much as rugby players should not belong to separate unions based on sex or any other factor, it is of paramount importance to work towards a solution of the union exclusion experienced by Midwest clubs and others.
- 3.) A proposal should be introduced to USARFU to recommend that all unions integrate women's teams on the local and territorial level.

Other topics of discussion included territorial divisions, select side competition at the local and regional level, and club championships - sighted for 1981. In the championships each territory would send their best team to compete against the other three territories.

In 1975, with a total of five teams, the Southern California Women's Rugby Association was formed. In four years that original number has more than tripled, with sixteen member clubs and two affiliates. The Eleanors, UCSD, Belmont Shore, Ombush, and SDSU were our initial members. Susie Stiers of the Eleanors served as the Associations first President. A special tribute goes to Jeannie Salisbury. Through her foresight and persistence the Association was admitted to the Southern California Rugby Football Union, making SCWRFA The first women's association to be admitted to a union in the U.S. This was no small task considering the climate at that time. The resistance of male clubs towards women ruggers was intense. We appreciate her successful representation.

The Union is an arm of the Pacific Coast RFU, belonging to the USARFU. Our Association is entitled to one vote representing all sixteen clubs.

# LAW CHANGES for '79 - '80

The changes in the Laws, which are summarized below, went into effect August 1, 1979. They are reprinted here with the permission of Jennie Redner - editor of IN SUPPORT.

- Law 1. Ground The term "playing area" refers to the field and the in goal-area.
- Law 6B Touch Judges In certain matches, the Union may appoint referees as touch judges who will assist the onfield referee in spotting instances of foul play.
- Law 8. Advantage The advantage law now applies to the 22 meter drop out and the kick-off. An improper kick or one not taken from the proper place (kick-off) will not automatically be called back as in previous years.
- Law 16 Fair Catch (Mark) The fair catch will now be awarded only to a player standing behind her own 22-meter line.
- Law 17 Knock-on

  A knock-on occurs when the ball travels forward toward the direction of the opponent's dead ball line after a player loses possession of it. A knock-on occuring in the field of play and traveling into the in-goal area and was there grounded, previously resulted in a 22-meter drop-out. From now, on a scrum will be awarded at the point of the knock-on.
- Law 19 Lying On or Near the Ball Players of either team must not wilfully fall on or over a player who is lying on the ground with ball possession, or on players lying on the ground with the ball between them.
- Law 23 <u>Line-Out</u> The ball must now be thrown into the line-out without delay once all the players, who are not loitering, have lined up.
- Law 24B Wheeling Scrums If a scrummage has wheeled 180°, the number 8, provided she has continued to bind throughout the wheel, is permitted to detach and immediately play the ball as it emerges from the second row.
- Law 26 is now entitled "Foul Play", defined as any action by a player which is contrary to the spirit of the game, and includes: obstruction, unfair play, misconduct, dangerous play, unsporting behavior, retaliation and repeated infringements. IMPORTANT... new Note 6 states: A player shall not take the Laws into their own hands, nor willfully do anything that is dangerous to an oponent, even if the latter is infringing on the Laws. It is illegal to willfully hack, kick, trip or trample an opponent.
- Law 28 Free Kick A goal shall not be scored by a kicker from a free kick unless the ball has first been played by another player.

Southern California has two brand new teams this season - the Santa Monica RFC and Esprit de San Diego.

Many of the Santa Monica women played for UCLA last year and have now graduated. Ellen Cunningham is their new President. The team is still currently looking for a

coach.

Esprit de San Diego is being coached by Nadine Erickson, formerly of Colorado State and Indiana U. WRF Clubs, and Angie Ludi, formerly of Ombush. V. Bennett is their new President.

SCWRFA welcomes you! We wish both clubs a successful first season.

# OMBUSH CHANGES NAME

Ombush would like to announce the interest of a new sponsor, Fred Thompson. Owner of the Guadalajara National Philharmonic (a five piece all women band), Mr. Thompson sponsors various athletic teams.

Our goal is not to convert all women to play rugby. Our goal is to enjoy a sport we love despite social opposition.

.... As Jack Scott once stated:

The value of women having the opportunity to participate in competitive sport has a social significance far beyond the world of athletics. When people have the freedom to truly choose what form of human movement best suits them . . . then both society as well as the physical education and athletic profession will be much saner. This will happen only when people abandon their obsession with being "masculine" or "feminine", and concern themselves with being human.
